**Anthony Gallup-** has complaint against neighborhood dog. He says it barks all the time, Todd asked him if he had called Brian Kellogg the Animal Control Officer, regarding the barking dog. Anthony said he had called him last week at midnight, but got no answer and no call back. We have a noise ordinance in place and Todd mentioned to Anthony if the dog was bothering him and it was after 10pm it would fall under the guidelines of the noise ordinance and he could call the Police Department, but if it was before 10pm to call Brian Kellogg, as he is the Town's Animal Control Officer. He also mentioned talking to the neighbor with the barking dog to let them know that the dog is bothering him. Brian said that he would also call Ms. Rapp to let her know that there has been another complaint regarding her dog barking.
