PERMIT FOR FIREWORKS

APPLICATION PACKET

The right to grant permission for shooting fireworks resides with the Selectboard of the Town of Morristown. You must **read and agree** to **ALL** of the following guidelines below before submitting your request to the Town of Morristown for approval.

1. Applications must be submitted to the Town Administrator's Office at least **30 days** before the date chosen for your fireworks display to insure consideration for that date.
2. An application fee of \$50.00 must accompany this form.
3. Requests may be made for one (1) calendar-year day only per application. One alternative rain date is allowed.
4. You must notify the following Officials prior to submitting application:
 - a. Fire Warden Dennis DiGregorio _____ was notified on this date: _____
 - b. Lamoille County Sheriff's Dept. (888.3502), was notified on this date: _____
5. You must also notify LCSD Dispatch the day of your display.
6. All fireworks displays must end prior to 11:00P.M. EST.
7. Proof of ATF License must be on file with the Chief of Police to conduct a 1.3 (Class "B") fireworks display.
8. Certain information regarding approved applications will be published by the Town in the local paper of record prior to any fireworks display. This will include: date of display, times of display and physical location of display. Public concerns can be addressed to the Town Administrator's Office.
9. Any violations of the terms and conditions included in this application packet are subject to a civil penalty of up to \$500 fine as per Town Ordinance (Article 0807-2B. Sec. II).
10. Approved Permit must be available at all times during the exploding of the fireworks and must be shown to any Enforcement Officer upon request.
