

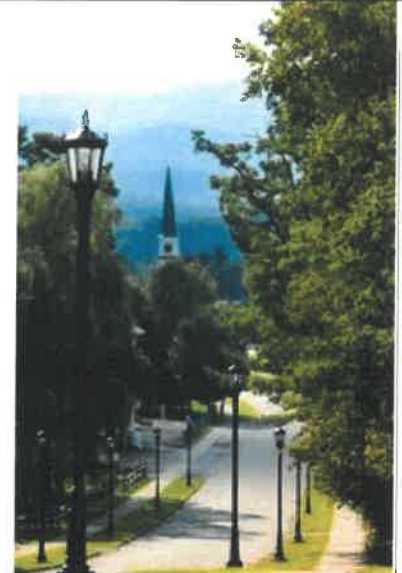

## Morristown at a Glance

Morristown is a rural town of more than 5,000 people (5,227 according to the 2010 census) located in the center of Lamoille County and serves as the region's center for commerce, services and industries. Morristown is situated in a valley along the winding Lamoille River and is nestled among the Green Mountain and Worcester mountain ranges. The famous Long Trail traverses the mountain ranges located here. Morristown is located 45 miles northeast of Burlington, Vermont's largest city and 30 miles northwest of Montpelier, the State Capital.

Many people often ask the difference between Morrisville and Morristown. Morrisville is a village located within the Town of Morristown. Located within the Village limits are various amenities including the local schools, Municipal Offices and Copley Hospital. Mail in Morristown is actually delivered to Morrisville addresses because the Post Office is located within the village limits of Morrisville.

Morristown provides many great opportunities for the community to come together. One of the many ways people hear or read about local events is through the radio station 93.9 WLVB or in the local weekly newspapers. Official notices are published in the News & Citizen newspaper. ## History of Morristown

On November 6, 1780, the General Assembly of the Independent Republic of Vermont granted Dr. Moses Morse his petition to establish a land grant in the north central part of the State. On August 24, 1781 Governor Thomas Chittenden issued the Town's Charter. By 1791, there were ten inhabitants that had moved from New York and Massachusetts and two Native American Indians from the St. Regis Tribe. By 1795, there were enough settlers to establish a tavern that held the first school, a town house and a brick church. It is the only town in the county that has gained in population by every census but one since it was created. In the late 19th century, much of the growth was directly related to the arrival of the railroad that also helped to create the unique style of architecture seen about town. The hospital and one of the country clubs located in Town are named after Alexander Copley, a philanthropist who donated much of the money for their construction. Copley also donated a large sum of money for the construction of the Town's high school that is currently called Peoples Academy. The Town Clerk's Office sells history of Morristown books if you would like to learn more about our history. We also encourage you to visit the Noyes House Museum located in the historic village of Morrisville. Since 1952, the Morristown Historical Society has leased the Noyes House to house their growing collection of Morristown and Lamoille County artifacts, documents and historic images. ## Municipal Offices

The Morrystown Municipal Offices are located at 43 Portland Street, diagonally across from the Post Office.



### Administration Office

The Administration Office is responsible for the day to day operations of the Town and serves as the liaison to the Town Selectboard as well as the Town's Village and Highway Road Crews. The Administration Office is available to answer any questions regarding any Village/Highway road or sidewalk concerns, annual budget, ambulance billing or general questions for the Selectboard. The Selectboard meets every other Monday at 6:30 PM at the Municipal Building. ### Town Clerk's Office

The Town Clerk's Office provides many services to the public including registering people to vote, registering dogs, issuing marriage licenses, certifying copies of vital records and recording land records. Other services provided in cooperation with State Agencies include: posting land, processing DMV registration renewals and issuing Green Mountain Passports. Notary services are provided free of charge; a photo ID card must be shown as proof of identification. The Town Clerk's Office is open to the public Monday, Tuesday, Thursday & Fridays from 8:30 AM to 4:30 PM and Wednesdays from 8:30 AM to 12:30 PM. ### Listers' Office

The Listers office is responsible for assessing all personal and real properties subject to taxation in Morrystown, preparing the grand list & conducting grievance hearings. This office is open Monday - Friday from 8:30 AM to 12:30 PM and afternoons by appointment only. Morrystown properties were reappraised in 2007 and before that in 2003. ### Zoning & Planning Office

The Planning & Zoning Department is responsible for all permitting, zoning, development and planning issues in Morrystown. Permits are required for all structures, changes of use and land subdivisions. Todd Thomas, the Town Planner, also serves as the Town's Health Officer. ### Community Development Coordinator

The Community Development Coordinator aids in working with municipal boards, commissions, community groups and businesses to identify & implement activities of the Town to enhance the community. ### Police Department

The Town of Morrystown has a full service Police Department that provides 24 hour service to the community. They are responsible for all safety & emergency activities in the Town. For non emergencies, contact them at 888-4211.

### Fire Department

The Morrystown Fire Department provides dedicated volunteer service to our community by protecting lives and property. They have been serving the community since July 13, 1890. ### Emergency Medical Services Department

The Morrystown EMS Department is a BLS & ALS ambulance organization comprised of volunteers and paid staff, serving the residents of Morrystown and surrounding communities. EMS is highly dependent on volunteers and always looking for more. ### Recreation Commission

The Morrystown Recreation Commission is a volunteer group endeavoring to provide the community with varied year-round activities for all ages. The Recreation Council runs a summer recreation program for elementary aged students that promotes healthy eating and exercise.

### Water & Light Department

## Elections/Important Contact Numbers



### Registering to Vote

To register to vote in Vermont, you must be a US citizen, a resident of Vermont & 18 years or older on or before the next election. You must register to vote in the town where your residence is located. If you have never registered to vote in Vermont, you must also provide a State issued ID & take the voter's oath. If you have decided to vote, the deadline to register to vote for any particular election is the Wednesday prior to the election by 5:00 PM.

Absentee voting is available for every election as soon as the ballots are ready, approximately 30 days prior to the election. The deadline to request an absentee ballot is the Monday before each election by 4:30 PM.

### Elections

Unless otherwise indicated, the polling location is the **Morristown Municipal Building** at 43 Portland Street and polling hours are **8:00 AM to 7:00 PM**.

- \* **Annual Town & School Meeting (Floor Vote):** 1st Tuesday in March; floor vote on Town budget, Town officials & other warned articles. Starts at 9:00 AM at the **Peoples Academy High School gym** at 202 Copley Ave.
- \* **Annual Town & School Meeting (Australian Ballot):** 1st Tuesday in March; Australian ballot vote for Town Selectboard, School Board members & School budget. Coincides with Town Meeting election.
- \* **Presidential Primary:** 1st Tuesday in March every four years; vote for party nominations for United States President. Coincides with Town Meeting election.
- \* **Village Meeting:** 2nd Monday in April at 6:30 PM, vote for Village officials and warned articles.
- \* **Vermont State Primary:** 4th Tuesday in August every even year; vote for party nominations for State officials.
- \* **General Election:** 1st Tuesday in November every even year; vote for State officials, Justices of the Peace. Every four years vote for US President & Members of Congress.

# Tax Billing

The Town of Morrystown operates on a fiscal calendar (July 1 to June 30).  
The Village of Morrisville operates on an annual calendar (Jan 1 to Dec 31).

Bills are sent out from the Town Treasurer at least 30 days before the first installment is due on November 15, 2016. You will receive only one bill for the current tax year, and it will include coupons for the first and second installments of your Morrystown tax bills. The bill that you receive will also include applicable Village taxes. **You will NOT receive a second notice of payment due for the second installment due on May 15, 2017.**

By law, taxes are levied on both real and personal property as it exists in the owner of record on the April 1st prior to the fiscal year start date of July 1st. Tax bills are mailed to the April 1st owner of record at the address on file with the Listers' Office. If all or a part of the taxed property is sold, it is the seller's responsibility to forward the tax bill to the new owner. **Failure to receive a tax bill does not relieve any taxpayer of responsibility to pay the property taxes, interest or penalties when they become due to the Town of Morrystown. Currently dated checks should be made payable to the Town of Morrystown and mailed to PO Box 748, Morrisville, VT 05661. Post dated checks or other checks not meeting the requirements will be returned, and penalties will be added if applicable. All checks returned by the bank will cause the tax payment to be cancelled, any receipt issued will be void, and delinquent penalties will be added. Payments are due in the hand of the Treasurer by 4:30 PM on the due dates. Only official U.S.P.S. cancellation marks will be considered timely. For a receipted copy of the tax bill, you must send a self addressed, stamped envelope with your payment. To properly credit your account, we would appreciate it if you would return the installment coupon with your payment.

### **FIRST INSTALLMENT – DUE NOVEMBER 15, 2016:**

Interest charges of 1% per month for the first 3 months and 1 1/2 % per month thereafter as provided in 32 V.S.A Section 5136, will be added to the unpaid first installment of taxes after the close of business at 4:30 PM on November 15, 2016. **Only official U.S.P.S. cancellation marks will be considered timely. *Post-dated checks will be returned.*** After May 15, 2017 any unpaid balance of this first installment will be delinquent and subject to an 8% penalty, 1 1/2% interest per month, and all collection costs.

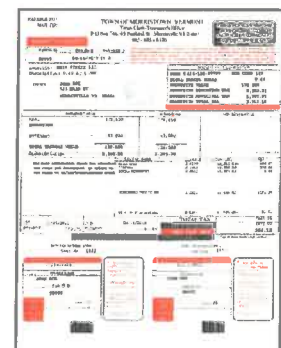
### **SECOND INSTALLMENT – DUE MAY 15, 2017:**

An 8% penalty on the entire unpaid tax due plus collector's costs and interest charges of 1% per month for the first 3 months and 1 1/2 % per month thereafter as provided in 32 V.S.A. Section 5136, if payment is not received in the office at the close of business at 4:30 pm on May 15, 2017 **Only official U.S.P.S. cancellation marks will be considered timely. *Post-dated checks will be returned.***

**IMPORTANT:** You can pay property taxes more frequently than the two installments. Our system is capable of receiving tax payments weekly, monthly, quarterly or whatever way accommodates your budget, as long as the taxes are paid in full by the due dates.

### **Escrow**

If a property owner has his/her property taxes held in escrow by a mortgage company, the Town will no longer forward a copy to the institution without a written request. The property taxpayer must contact the escrow service with all the information included on the property tax bills.

# Homestead Information



## Homestead Declaration

Homestead Declarations must be filed each year so that you are correctly assessed the homestead tax rate on your property. A “homestead” is the principal dwelling and parcel of land surrounding the dwelling. Declare your homestead by filing Form HS-122 if you are a Vermont resident and you own and occupy a homestead as your domicile as of April 1, 2016. A principal dwelling that is fully leased on April 1, 2016, is still a homestead if it is not leased for more than 182 days in 2016.

## Property Tax Adjustment Claim

Homestead owners may be eligible for a Property Tax Adjustment based on their housesite value and their household income. The Property Tax Adjustment is a credit applied against your property tax bill. The credit is reflected on your 2016/2017 property tax bill as a state payment.



Property Tax Adjustment Claims are made to the Department of Taxes by filing Form HS-122, Section B. To be eligible for a Property Tax Adjustment Claim, you must (1) have been a Vermont resident all of calendar year 2015; (2) not have been claimed as a dependent for tax year 2015; (3) have property as your homestead as of April 1; and (4) have declared the property as your homestead on the 2016 grand list. You may be eligible for a Property Tax Adjustment even if you do not have a requirement to file a Vermont income tax return. ## Vermont Use Value Appraisal Program

Owners of agricultural and forest land may be eligible to have land taxed at the lower “use value” rate by enrolling in the Current Use Program. At least 25 acres are required for enrollment, but there are some special eligibility criteria for smaller active agricultural parcels. Farm buildings can also be enrolled in the program. Applications are due by Sept 1 in order to enroll for the following tax year. ## Veterans Exemption

In Morristown, the first \$40,000 of appraised value of the established residence of a qualifying veteran, his or her surviving spouse or child is exempt if:

- \* the residence is owned in fee simple by one or jointly and;
- \* a written application for the exemption is filed with the Vermont Office of Veterans Affairs (VOVA) before May 1.

## Grievances

Property owners may grieve the assessed value of their property by submitting a written notice of appeal to the Board of Listers on or before the date that grievance hearings are held - sometime after April 1st. Call the Town Office for the specific date. If your property has been improved (with an addition, for example) or if the town has conducted a town-wide reappraisal, you will receive a “change of appraisal” notice. The date for grievance hearings will be specified in the change of appraisal notice. Please note that you may grieve your assessment even if you do not receive a change of appraisal notice. Mail your notice of appeal to: Board of Listers; Town of Morristown; PO Box 748, Morrisville, VT 05661. The written notice of appeal should include the name, mailing address, and phone number of the property owner, the parcel ID # of the property that is the subject of the appeal and the reason for the appeal.

## Dog Licensing/ DMV Renewals/Green Mountain Passports

### Dog Licensing

By law, all dogs and wolf hybrids six months of age or older must be licensed by April 1st each year in the town where the dog resides. Licenses are only available through the Town Clerk's Office and may be purchased in person or by mail if there is a current rabies certificate on file. Licenses are available after mid January each year. Morristown does not currently license cats.

*In order to license your dog you must present the following items:*

- A copy of a valid rabies certificate (unless one is already on file).
- Proof of Spay/Neuter certificate (if applicable)
- Cash or a check made payable to "Town of Morristown" for proper fees.



#### Fees:

##### *Before April 1<sup>st</sup>:*

Neutered/ Spayed: \$4.00 + \$5.00 state = \$ 9.00  
 Male/ Female: \$8.00 + \$5.00 state = \$13.00

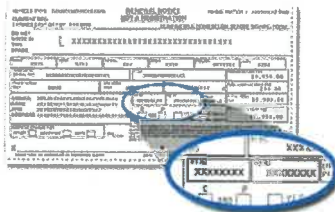
##### *After April 1<sup>st</sup>:*

Neutered/ Spayed: \$ 6.00 + \$5.00 state = \$11.00  
 Male/ Female: \$12.00 + \$5.00 state = \$17.00

### DMV Renewals

Our office is able to issue temporary vehicle registration renewals. The receipt and sticker that are given out at the Clerk's office are only temporary and within a few weeks after paying, the state will send the appropriate stickers to you. You can also renew your registration online at:

*In order to renew your registration you need the following:*

- A preprinted renewal form from the DMV.
- The renewal form must be for current month or the previous two month period.
- A check or money order made payable to DMV. (NO cash accepted)
- A separate \$3.00 processing fee paid directly to the Town for each renewal. (Cash accepted)

### Green Mountain Passports

The Green Mountain Passport Program was started in 1973 by an Act of the Vermont General Assembly. Use your passport for free admission to Vermont State Parks (overnight camping and other fees are excluded), Vermont State Historical Sites and events which are fully State sponsored.

*To be eligible for a passport you must be a resident of Vermont AND:*

- 62 years old or older or
- A veteran of the uniformed services

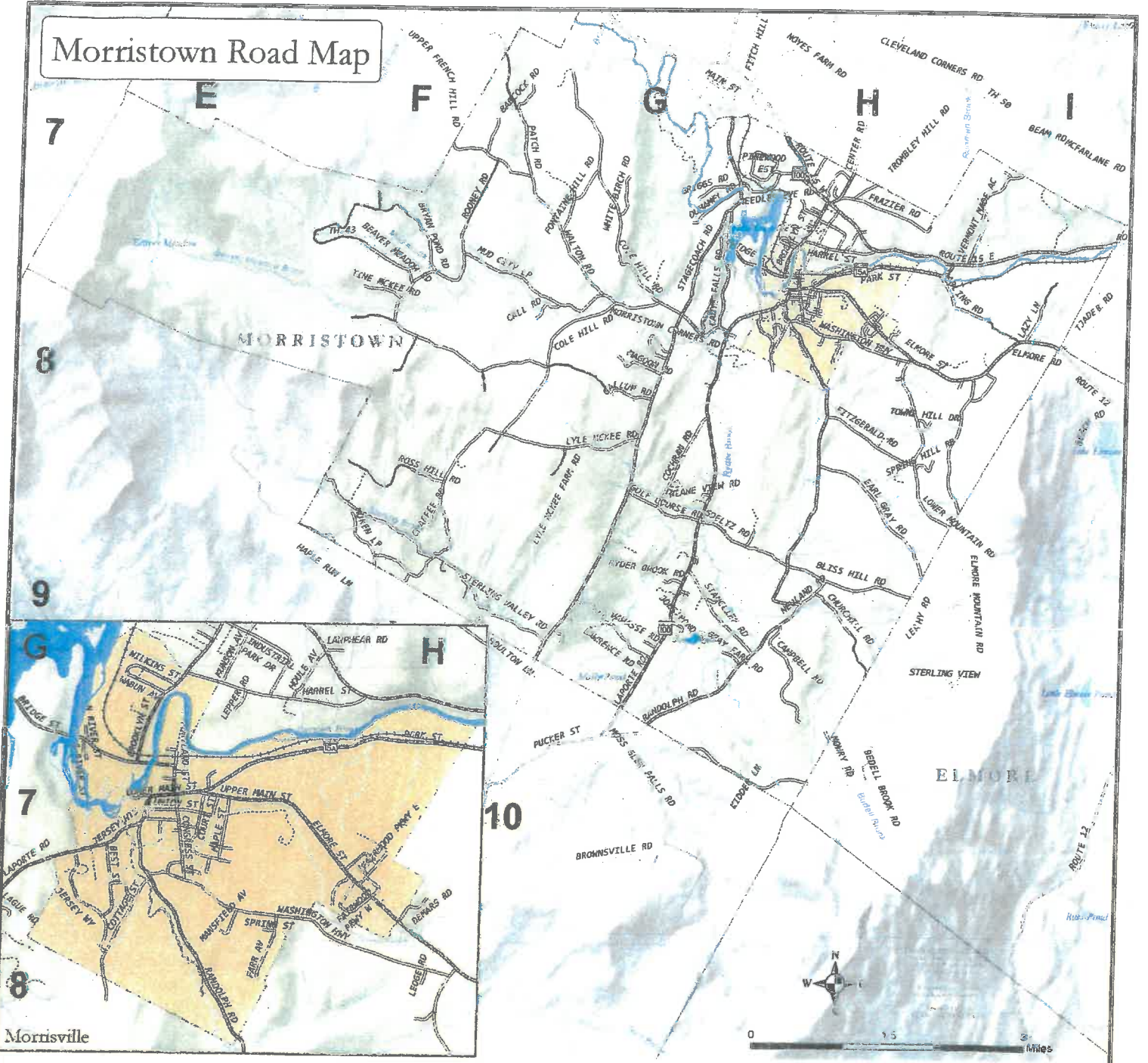

# Morristown Road Map

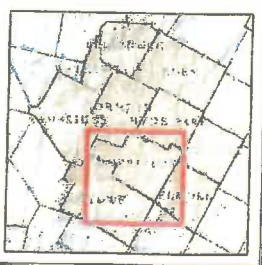
