- 1. Approve Letters of Support for Environmental Commission- The State environment Conservation is asking the Town for a letter of Support in Purchasing easements propert two different locations. A 15.4 acre parcel along the Bedell Brook, Dan Lindley Town Administrator did not see an issue with this as it is not useable land. The second parcel is 7.9 acre parcel located on Rt. 15 along the Lamoille River, this is zoned as a special industrial zone and is usable land. Dan Lindley, Town Administrator had concerns with State purchasing land that could later be developed. The Selectboard would like the Environmental Conservation to come in and talk with the Selectboard about this easement purchase before they send a letter supporting it.
